BEGINNING at an iron pin in the property line dividing lands now or late of Eva Beck and lands now or late of Harvey Wehr, this iron pin being located North 89 degrees West, eight hundred thirty-seven and seven hundredths feet (837.07) from the northeast corner of lands now or late of Harvey Wehr; Thence along lands now or late of Harvey Wehr North 89 degrees West six hundred seventy-five and seventy-five hundredths (675.75) feet to an iron pin in the center of Township Route #410; Thence the following two courses in and along Township Route #410 (1) North 6 degrees 45' West ninety-four and forty-five hundredths (94.45) feet to an iron pin; (2) Thence North 54 degrees 45' East three hundred eighty-eight (388.00) feet to an iron pin; Thence along the following two courses along land now or late of Eva Beck, (1) North 87 degrees 53' East three hundred seventy-seven and twelve hundredths feet (377.12) to an iron pin; (2) Thence South 1 degree 10' West three hundred forty-three and fifty hundredths (343.50) feet to the place of BEGINNING.
